Initial situation

Regulatory requirements are increasing in all areas, including banking. The topic of data governance is becoming increasingly important, especially in the wake of the new data protection regulations. As part of an initiative to establish internal data governance throughout the bank, BANK-now decided to procure software for the systematic analysis and monitoring of data quality. After evaluating several providers, the decision was finally made in favor of SAS (Statistical Analysis System) Data Quality Manager Studio 9.4.

After a successful PoC by the product provider SAS, adesso was asked to oversee the installation, the configuration as well as the future operation. The choice fell on adesso due to its expertise in the field of data governance around the business intelligence platform SAS.

Solution

The Data Quality Analytics solution introduced is the SAS 9.4 Data Quality Manager version M7. The adesso team supported the integration and configuration as well as the operation and the further development of the implemented SAS 9.4 Suite.

This implementation of the planned target solution was based on a three-stage installation procedure, whereby each of the three environment instances was staggered with the SAS 9.4 Suite being added to each of the environment instances.

For the use of the SAS 9.4 Suite, BANK-now designed a central data catalog that documented the required business rules. The translation of these business rules into the technical rules took place with the SAS Data Quality Manager. With the help of an authorization concept, user-friendly access to the required data was ensured, taking into account the respective roles and responsibilities of the corresponding users. Finally, the SAS Visual Analytics module was used to monitor the activities.

Customer benefit

The SAS 9.4 suite allowed an automated monitoring of critical data elements (CDEs) to improve data quality. The results can now be manually reviewed and specifically addressed by the respective data owners in the report using SAS Visual Analytics solution

Outlook

adesso has started its operations within the scope of a Managed Services offer and advises BANK-now on further functional enhancements of the introduced SAS solution. Based on the SAS expertise, further release upgrades (M8) are initiated on an ongoing basis.
